

Tashante is also the co-founder of The Stockton PEACE Transformation Prayer Team which is a collective of faith based community leaders who lead a daily prayer line and hosts community prayer walks. Tashante's newest vision The Exodus-The Blueprint For Healing is moving through the community encouraging individuals to prioritize physical, emotional, and spiritual wellness.
