Sue Parker was first elected and sworn in as Chief Clerk of the California State Assembly on January 9, 2020. Mrs. Parker is the 40th individual to serve as Chief Clerk since 1849 and the first woman to hold the position. Before becoming Chief Clerk, Mrs. Parker had been the Assistant Chief Clerk. In that role, she oversaw the operations of the Assembly Desk, advocating for the increased use of information technology to streamline the processing of bills and updated the official Chief Clerk website to allow greater access to the legislative process. She began her career as a Senate Fellow and has held many roles within the office of the Chief Clerk, including being the first female Reading Clerk.

The Chief Clerk of the California State Assembly is one of three nonmember, nonpartisan officers elected by the Members of the Assembly at the beginning of each two-year session. The Chief Clerk serves as the Parliamentarian of the House. Under the direction of the Chief Clerk, the Chief Clerk's Office is responsible for publishing the official documents of the House; and keeping all the bills, papers, and records of the proceedings of the Assembly.

As director of government affairs, Luis helps craft and drive City of Hope's government relations efforts at the federal, state, and local levels. Carol McGruder is a seasoned veteran of California's tobacco control experience. Carol is a senior project director, activist, researcher, and writer. She has worked in tobacco control since 1994. She is experienced in the fields of public policy, social marketing, media advocacy, global tobacco control, health education, community capacity/power building, and leadership development. She is a proud co-founding member and Co-Chairperson of the African American Tobacco Control Leadership Council (AATCLC). Created to inform the direction of tobacco control policy, practices, and priorities, the AATCLC works at the intersection of public health policy and social injustice. The AATCLC has been at the forefront of the national movement to restrict the sale of mentholated tobacco products, assisting municipalities across the country. They have fought resolutely against the decades of racialized tobacco industry targeting of the Black community and the resulting 45,000 Black lives lost each year from tobacco-induced diseases.

Carol and the AATCLC have received honors and accolades from many organizations including the Public Health Law Center, SRNT, American Legacy Foundation, and the San Francisco and Berkeley Branches of the National Association for the Advancement of Colored People. She served as NAACP Branch President for Berkeley, CA for two terms. She received the prestigious Biddy Mason "unsung shero" award in 2021.

He also holds a Master of Public Health from Emory University and completed a Fellowship in Injury Epidemiology at the Harvard School of Public Health.

Dr. Abraham is currently the President of the Los Angeles County Medical Association LACMA, Trustee of the California Medical Association CMA, and Vice Chair of the American Medical Association AMA Council on Constitution & Bylaws. Additionally, Dr. Abraham is a member of the National Medical Association NMA and serves on the Board of Directors of the Charles R. Dr. Amber Johnson is a teacher, public health scholar, and community leader. Dr. Johnson's career has focused on reducing inequities and disparities among marginalized populations. Dr. Johnson is currently an Associate Professor in the Department of Health Science at California State University at Long Beach. She uses this position to inspire and embolden the next generation of leaders to develop innovative solutions to public health challenges facing our society. Dr. Johnson has developed partnerships with colleges and universities, nonprofit organizations, and local governments to conduct community empowered research projects, HIV prevention, community health prevention education community health assessment, and outreach. Currently, she is funded by the National Institutes of Health to study how discrimination, emotion, and cardiovascular disease risk factors can lead to health disparities among Black women.

Dr. Johnson has been actively involved in promoting equity in the City of Long Beach. She has assisted the City of Long Beach's city-wide equity efforts by conducting a qualitative analysis of townhall and listening sessions during the 2020 Framework for Reconciliation. She also leads the Black Health Equity Collaborative, a collaborative of Black serving organizations whose mission is to address health inequities and disparities in Black communities through one powerful voice.

Dr. Johnson has received numerous awards for her teaching, research, and service to the community. She also enjoys membership in national organizations including the American Heart Association, American Public Health Association, American Psychosomatic Society and Delta Sigma Theta Sorority, Incorporated.

Ms. McGee ensures timely and effective completion of policies and initiatives through an equity lens. She is a strategic advisor to the Supervisor and senior deputy staff. She also manages team operations including personnel, administrative, budget and constituent engagement matters. She also creates and maintains processes to streamline operations to best serve the needs of the 2nd Supervisorial District.

She has received several awards including recently receiving the 2019 Frances Newell Carr Award from Women Lawyers of Sacramento and being named Sacramento County Bar Association's 2016 Distinguished Lawyer of the Year. In 2015 she was recognized by the National Coalition of 100 Black Women, Sacramento, the Yvonne Brathwaite Burke Award from the California Legislative Black Caucus, the Sacramento Business Journal's Women Who Mean Business Award, the Wiley Manuel Bar Association named her the 2013 Attorney of the Year and The Recorder named her one of 40 Women Leaders in the Law for 2012 for her networking skills. In 2011, the California Legislative Black Caucus awarded her the Martin Luther King, Jr. Civil Rights Leadership Award and she was identified as one of the Top 100 Political Warriors by the Capitol Weekly. She received the Wiley Manuel Law Foundation's 2008 Diversity on the Bench award, the 2008 Lawyer of the Year award from California Association of Black Lawyers and also named California Lawyer's Attorney of the Year and one of the Daily Journal's Top 100 Lawyers of 2007.
